**Subject: COMPLAINT AGAINST EXECUTIVE DIRECTOR RIFFAT SULTANA, KEY PUNCH OFFICER FAISAL & ACCOUNTS OFFICER ASIM JAMAL POSTED AT KARACHI INSTITUTE OF HEART DISEASES, KARACHI AND OTHERS REGARDING MISUSE & MISAPPROPRIATION OF GOVT. FUNDS AND CORRUPTION**

**WHEREAS**, the above captioned inquiry has been assigned to the undersigned with the approval of Competent Authority for verification and submission of report as provided under Sindh Enquiries & Anti-Corruption Rules 1993.

*The applicant alleged that the Executive Director Riffat Sultana, has recently appointed a pathologist without obtaining approval from competent authority i.e. Board of Governors. Similarly the Key Punch Officer Faisal and Accounts Officer Asim Jamal are involved in corruption and corrupt practices by misuse and misappropriation of government funds and resources of the Institute and also made illegal assets. Furthermore, their appointment is also illegal and without approval of Board of Governors. The tenders/work orders are awarded to the blue eyed/favorite persons/relatives repeatedly from last three years without following the procedures. The canteen has also been awarded without approval from competent authority i.e. Board of Governors.*
